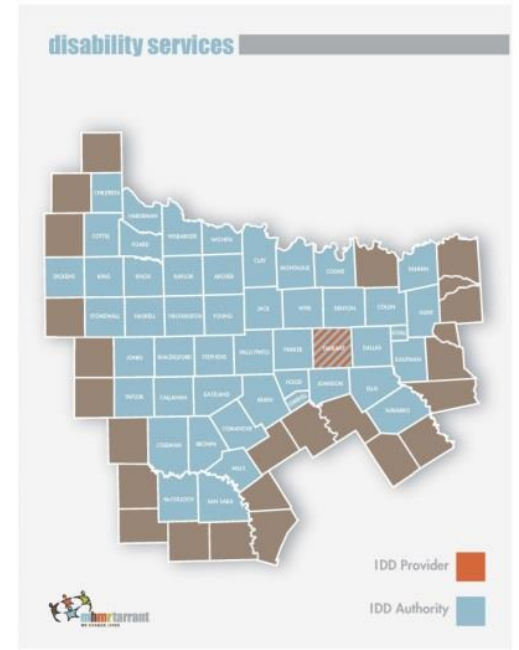

MHMR DISABILITY SERVICES INTAKE AND ACCESS ELIGIBILITY

- Each IDD service has its own rules.
- In Texas, your local IDD authority will determine if you can get services. To get services, **one of the following must apply:**
 - You must have a diagnosis of IDD, or
 - You must have a pervasive developmental disorder, such as autism, as defined in the current edition of the Diagnostic and Statistical Manual, or
 - You must have a related condition and be eligible for, and enroll in, a HHSC program that serves people with IDD, or
 - You must be a nursing home resident with a diagnosis of IDD or a related condition, or
 - You must be eligible for Early Childhood Intervention services.

- Call ICARE(817-335-3022) to get registered and screened.
- Schedule Intake Appointment
- Assist in applying for benefits
- Determination of Eligibility
- Refer for General Revenue Services
